**Assignment Title: Architect cum Structural Consultant for strengthening of Quarantine & Pre-quarantine Station at Sabarmati Ashram Gaushala, Bidaj Farm, Gujarat State**

The Government of India has received a credit from the International Development Association towards the cost of National Dairy Plan I (National Dairy Support Project). Sabarmati Ashram Gaushala (SAG), an End Implementing Agency of the Project now intends to apply a part of the proceeds of this credit to payments for consulting services.

The consulting services (“the Services”) include Architect-cum-Structural Consultant for building new quarantine and pre-quarantine sheds etc. The scope of work includes (a) To prepare preliminary Architectural & Structural designs as well as estimate of cost, (b) To prepare detailed working drawings for execution, (c) To analyses and design the reinforced concrete and steel structures and other buildings based on architectural drawings and (d) to workout and prepare estimate of quantities for all civil & structural work along with specifications. Total civil work under the project is estimated to cost around Rs.4.50 Crores. Period of assignment would be for 18 months.

SAG now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: (a) Turnover during the last 3 years, (b) Age of the firm (number of years for which firm is in this business) and (c) experience in similar projects, i.e. number of contracts executed during the last 3 years with civil works value of more than Rs.5.0 Crores.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011 (“Consultant Guidelines”), setting forth the World Bank’s policy on conflict of interest.

A Consultant will be selected in accordance with the Selection Based on the Consultant’s Qualification (CQS) method set out in the Consultant Guidelines.
